18/299 To note bank reconciliations

18/300 **Planning applications**

1. 17/00818/OUT | Residential development of approximately 3,200 homes...All matters are reserved except the primary means of vehicular access onto the A339, B3400 and Roman Road. | Manydown Land Off Roman Road And Worting Road Basingstoke.

After considerable discussion, the motion being proposed by Cllr Mahoney, seconded Cllr Botten, IT WAS RESOLVED unanimously that:

- The council wishes to object to the application on the grounds that the No Right Turn from the A339 into Rooksdown Lane means that all traffic from the south heading to Weybrook Golf Club, including cars and delivery vehicles, will access the club via Rooksdown Avenue and Gillies Drive, using residential roads that were not intended for this purpose. This would appear to transfer safety issues from the A339 to narrow residential streets and is unacceptable to the residents.
- RPC wishes to discuss the matter further with the Manydown project team and Borough councillors before making a more detailed

representation prior to discussion of the proposals by BDBC in June.

The clerk was asked to contact the project director and request suitable representation at the March RPC meeting.

2. Applications not on agenda None.

18/301 To receive an Allotment update - Clerk

The clerk reported that the transfer documents were still in the hands of Persimmon's solicitors and agreement had not quite been reached. It had also just become apparent that Vivid Homes would be co-signatories and therefore would need to review the transfer documents. This may further delay the process.

The clerk was asked to organise a meeting of the Allotments Working Group. Cllr Morris volunteered to join Cllr Mason as council representatives on the group.

Chairman's Report for Rooksdown Parish Council meeting – February 2019

My actions from last Parish Council meeting:

• 18/273 Grit Bins – Chairman will organise installation and filling of the new bins in Sherborne Fields

Grit bins have been installed - See item below.

 18/273 Chairman will raise the state of the roads around Squirrel Wood development with developer & James Holts, Hampshire Highways

The state of the roads has been discussed on site with Mark Glendenning (Homes England) on 29.1.19 who raised it directly with the Site Manager at Squirrel Wood. They acknowledges the issue and apologise for the state of the roads since the beginning of the year ... however, the state of the roads doesn't appear to have improved much since this intervention and therefore would suggest that we need to increase our representation for AllenBuild to respect the residents of Rooksdown who have had to put up with this mess & inconvenience for nearly a year now ... and have many years to come ... reminding them that Rooksdown is a residential site and not just route towards their building site.

 18/273 Chairman to provide evidence of excessive speeding during school access times to Cllr Taylor to help with the discussion with regard to school parking, safety, traffic and danger to children

This data takes several hours to pull together but will be prepared well ahead of the proposed meeting in March.

GRIT BINS in SHERBORNE FIELDS


Thanks to Cllrs Mason & Lovett for helping me install the recently purchased grit bins for Sherbone Fields, positioning them:

- St Catherine Road,
- Junction of St Anthony Rd/St Catherine Road,
- Wadham Gardens
- Keble Road.

It looks like we made it just in time for the bad weather that gripped us at the end of January, making it a safer place to live for residents.

The message opposite was posted on the Sherborne Fields Facebook page ... and was generally well received.

It appears that a large number of the residents have been complaining to the managing agent HML about what they get for the service charge they have to pay (including, amongst other things, grit bins).



I know that Cllr Bound has arranged for a resident meeting regarding the management company on Monday 4 March where his trying to organise both a director of the Sherborne Fields Management Company and the Managing Agent (HML) to attend. We look forward to an update following the meeting.

On a separate note, it was great to see the community spirit in Rooksdown during the recent bad snow at the end of January / beginning of February ... Rooksdown being a great place to live.

I know that at least 8 different people helped me to get my car off the development so that I could get to the airport on 2 February ... for which I am most grateful.

Cllr Bound & I had a meeting with Mark Glendenning (Homes England) and James Holt (HCC) at Squirrel Wood in regards to the state of the flooded footpath on Tuesday 29th January.

Mark then spoke to Bryan Hare (Ops Director) & Joseph Stewart (Site Manager) who agreed to build a deeper 'French drain' trench along the edge of the site to hold more water and to prevent water run-off & chalk leaching from the site.

Bryan also added that it was his intention to produce a resident bulletin to give an update on progress and to explain what had caused the issue with the chalk & slurry on the footpath.



Contractor Delivery Signage across Rooksdown

After many months of working with Mark Glendenning and as raised in previous updates – the construction traffic signs have now been installed around the development (as per below) following sign off from Hampshire Highways.



This should help with the issues of construction traffic travelling the wrong way around the development ... which has not been a great experience for the residents of Rooksdown. Also, in some place, contradictory signs can now be removed.

Residents should continue to highlight when they see construction traffic using the wrong routes around Rooksdown. We need to ensure that we highlight to the different sites where contravention of construction routes is identified, to ensure the safety of residents and keeping *Rooksdown as a great place to live*.

Maintenance of bins / benches

A number of the bins & benches around Rooksdown that looked rather dirty and uncared for (or had been vandalised) originally highlighted by ClIr Botten during 2018 have now been renovated following on from my request & meeting with Alan Tully on 15th January ... making Rooksdown a great place to live for all residents
