Action

19/76 To receive and accept apologies for absence

Apologies were received from Cllr Lovett (work commitments), Harris (illness), and Morris (illness). County Cllr Taylor also gave his apologies (holiday).

19/77 To receive and note any Disclosable Pecuniary Interests and requests for dispensation for items to be discussed

19/78 To approve the minutes of the Rooksdown Parish Council meeting of 20 May

The motion being proposed by Cllr Mahoney, seconded Cllr Botten, **IT WAS RESOLVED** unanimously to approve the minutes.

19/79 To discuss matters arising from the minutes

- 18/182 and 18/214 Apply to BDBC for bus shelters Cllr Lovett carried over as Lovett

- 18/273 Parish and Town Council Investment Fund still waiting for dates from Cllr Taylor
- 19/7 Improvements to pedestrian crossings for the school awaiting further information from Glen Parkinson of HCC Clerk to chase

- 19/35 LIF Update on LIF bid Cllr Payne because of the complexity of the documentation required and the early deadline no submission was made in this round

19/80 To invite members of the public to address the meeting (up to 15 minutes in total)

A member of the public asked:

- For confirmation that that no construction traffic for Squirrel Wood was allowed
 to access the site down Mill Rd. Cllr Bound confirmed this was the case, and Cllr
 Mahoney asked him to report breaches to the site manager. Cllr How will also
 report this to the site.
- Other than yellow lines, can anything else be done to restrict non-resident parking? Cllr Bound stated that yellow lines have been put where allowed and required. Once adoption of the all the roads is complete a consultation with the appropriate authorities is needed.

19/81 To consider improvements to the Skatepark – Cllr Payne

Cllr Payne summarised the request for improvements (see appendix 1). The main uncertainty was the effect that the new skatepark in the Memorial Park would have on the usage at Rooksdown.

The feeling of the meeting was to wait until the Memorial Park skatepark is complete and see whether the Rooksdown numbers drop. The expected completion date is August 2020.

Cllr Payne agreed to contact the originator of the request and to get an estimate of costs from supplier for various types of extension.

19/82 To discuss the impact of the proposed No Right Turn (NRT) to Rooksdown Lane and consider the next steps

The Chairman confirmed that a letter summarising the situation had been delivered to all the households likely to be affected by the change asking them to put their opinions on the BDBC Planning Public Access System. As of today, 33 neighbour comments had been put on the website.

Sandy Burrell from the golf club was invited to join the discussion. He expressed surprise that the club had not been consulted by BDBC, especially as they had commented on the original Manydown Traffic Impact Assessment (TIA). He stated that the NRT was a major issue for the club as most traffic approached from the Basingstoke direction and would be rerouted through Gillies Drive. which would be unacceptable. He believed a new junction should be constructed on the A339, and this appeared possible as he had been informed the areas to the north east of the junction were owned by BDBC and HCC. There seemed no reason why these shouldn't be utilised.

He also said that they had measured the traffic flow in 2014, when they had counted about 360 movements per day on average. This was when the course only had 18 holes. The proposed development of 27 holes is expected to be completed in early 2020 and the flow would therefore be considerably higher – much greater than the figure of 200 used by SYSTRA in the TIA. It is expected to be at least double that figure per day once the development has been completed. He offered to copy the traffic flow report to RPC.

The Clerk was asked to contact the Manydown Project Team to ensure they are aware of these traffic flow figures.

The golf club will be making a comment directly to BDBC.

19/83 To receive reports from:

- 1. Chairman of Rooksdown Parish Council
 - Police attended today to look undertake speed enforcement following the Chairman's campaign. They issued fines and warnings to a number of people and were planning to make more enforcement visits. The Chairman provided the latest data which has been collated from the Speed camera which has been sited on the corner of Park Prewett Road / Mill Road (see Appendix 2). The Chairman has been in contact with David Wilson Homes due to the state of the roads coming from the Gillies Meadow development, the speeding of the contractors who are working at the development, the state of the weeds that are Rooksdown resident facing at the blue hoardings on Park Prewett Road and the kick around area which has become greatly overgrown. Chairman has expressed his disappointment to the management team who seem to have taken their eye off the ball in this regard.

- Southern Area adoption update:
 - All highway works at the Squirrel Wood junction is complete the gully grates have been replaced as requested by HCC. Final works/quality inspection are to take place this week.
 - Road Safety Audit inspection has been requested but no date provided yet. This is with PBA for Allenbuild and having spoken to them today they expect this to be in the next week to 10 days.
 - The Deed of Dedication is agreed we are waiting for HCC's solicitor to issue an engrossment
 - Updated Works Plan was issued by Taylor Wimpey last week and we are waiting for HCC's confirmation.
- 2. Clerk to the Parish Council Taylor Wimpey had raised an issue concerning the handover of the car parks, as BDBC might be expecting the land as part of the POS. The Clerk was asked to check with Sooh Boocock (BDBC).

Appendix 1: Skatepark extension briefing - June 2019

Edited version of enquiry from member of the public

I am writing to ask how I can go about applying to add something to the Rooksdown skatepark to make it a safer space for all of us. The proposal is for the addition of a flatground space: a square and flat area of concrete for people to try flat ground tricks. Skateboarders especially do this to warm up and to learn new flips etc. Currently the area at the top of the ramps is being used for this, making it congested and dangerous. It seems to be something that all users would like added.

I am a frequent user of the park and see the congestion all the time: when there are 4-6 skateboarders skating flatground we are in people's way and they are in ours, making it dangerous. The space could also include a flat rail and a ledge so people of lesser abilities could learn grinds on something easier before stepping it up to the down ledges and rail.

Observations

- There are many improvements that could be made to the park, but this is probably the cheapest "add-on" on the list.
- A sensible location might be at the back, concreting up to the fence area, farthest from the path. Another
 option would be a flat pad on the other side away from the school, but this could incur challenges related
 to noise and space consumption. It probably could not be on the school side of the park, for reasons of
 noise.
- The sound barrier fence would probably be too expensive to move
- There are organisations such as the Tony Hawk foundation that might consider a small grant to fund something like this.
- The cost could be £15k because of design/mobilisation costs and tooling.

Concerns

- How will a proposed extension to the park be received by neighbours and other park users?
- Is it too small a project? Works like this can be seen as poor value because of the sheer cost of managing the process. Would it be better to ask for more?
- Where would the budget come from? What options do we have?
- What effect will the redevelopment of the skatepark in the Memorial Park have on demand in Rooksdown? This is scheduled to start this financial year.
