## 14. MATTERS RAISED BY COUNCILLORS/CLERK

- (i) Cllr Payne (JDP) suggested that parking permits/ limited waiting notices near the hospital might improve the situation. It was recognised that the installation of a bus gate(s) might have a significant effect.
- (ii) JDP also suggested that the provision of Farmers Markets in Rooksdown might be of benefit to residents. It was noted however that such markets had been held for some years in the Basingstoke Town centre on Sunday mornings and had not proved commercially viable.
- (iii) The Chairman reported that he had been to a BDAPTC meeting and had received information on Localism and how money can be raised by parishes.
- (iv) The Chairman referred to an earlier suggestion that RPC should purchase suitably worded polo shirts,

and it was agreed to formally consider a resolution at the April meeting that 10 such shirts be purchased.

## Police Report by PCSO Rob Nicklin (RN)

#### PC Nicklin reported:

- a. That the police are targeting thefts from vehicles, which take place not only at night but also during the day, by undertaking lots of patrols. 80% of drivers are leaving valuable items in their cars, and RN asked that residents encourage others not to do so.
- b. Thefts from vans has been prevalent in Basingstoke (20 in a week). Arrests have been made.
- c. There have been instances of cannabis smoking and dealing in Rooksdown and police have attended following reports of antisocial behaviour in Pillar Box Gardens. Police are adopting a zero tolerance policy and encouraged anyone to ring 101 immediately.
- d. Young people have been gaining access to a derelict building (PPH).
- e. Other complaints included neighbour disputes, generally due to complaints about noise. Sentinel Housing and BDBC Environmental health department are involved.
- f. The police plan to engage in interaction with young people in Rooksdown; this has had beneficial results in other areas.

# Update to Rooksdown Parish Council – 25<sup>th</sup> March 2013

#### **Update from Borough Cllr Karen Cherrett**

**Pavilions Management** – the formal planning application has still not been submitted by the landowners, HCA, and developers (Taylor Wimpey) and progress on this matter is being chased so that we can identify a likely timeline for resolution.

**Park Prewett Main Hall** - HCA and developers are close to concluding the pre-planning application discussions in preparation for formal submission. Contrary to rumours that circulated last month, there have been no approaches, formal or otherwise, to convert the building into a mosque. The outline plans for the Parish to take on the use and running of part of this building with a view to achieving a mixed use community and residential development are the only game in town at present and we look forward to the application coming forward for consultation. The Parish meeting in April will provide the first fully public opportunity for this discussion and it is hoped that local

The Parish meeting in April will provide the first fully public opportunity for this discussion and it is hoped that local residents will attend and share their views on the future plans for this much loved local landmark.

**Parking Park Prewett Road** – the hospital, Parish Councillors and PCSO's have suggested leafleting cars parked on the stretch of road leading into the roundabout junction to alleviate the parking concerns. No formal actions can be taken until the road is adopted and even then it will have to be a sufficient priority for the Police to take action on what is a residential road.

**Benefit changes, BDBC housing event** – the changes to welfare benefits and particularly, housing benefits, come into effect next month. It will have an impact for a number of our local residents. The council has made available a £500k fund in addition to the DWP fund to assist with cases of hardship and has also put in place additional support for home exchanges. Affected residents are encouraged to contact the council housing team or attend the open event on:

Resident enquiries – the following is a list of enquiries I am dealing with for local residents:

• Sheepwash and Downside Close – still waiting to hear of progress within county team to reach a resolution on the siting of low rail / bollards or cutting back the current verge to enable more parking space

**Bus gate / rising bollard and Moth's Grace / Crondall Terrace crossing point** – there is a meeting on 24<sup>th</sup> April to receive the results of the recent traffic monitoring survey and hear HCC's plans for traffic calming measures. Cllr Statham is attending and we all await the next HCC instalment with interest!

Free school progress – following last month's flurry of correspondence between the trust and HCC regarding plans and decision points for the school, it has all gone quiet again. I have chased but not received any response to my questions regarding exactly what community consultation is planned or indeed how local bodies will be engaged ahead of decisions being made in May/June.

Rooksdown Safer Neighbourhood Partnership (RSNP) – the Borough has seen an average 28% decrease in crime in the last 4 years with some areas seeing up to 46% reduction in reported incidents. Locally we remain a low-crime and ASB area and our local priorities set by the RSNP remain the pavilions and community centre ASB. Is there a view on whether we should continue with the separate quarterly meeting now that PC Ian Hoile has moved on or can we confirm that the Parish is content to deal with community safety matters through the existing Parish and RCA meetings? If this is the case, the Parish may wish to include a quarterly standing agenda item to review crime and ASB with attendance or report from our PCSO and beat officer.

**PC Hoile – vote of thanks** – the Parish may wish to move a formal vote of thanks to PC Hoile for his service to the community over the past 7 years and wish him well in moving on to his new role in support of youth offender rehabilitation.

## Planning updates - no update from last month

- Site selection within the SHLAA continues to progress within the process for determining the Local Development Framework. It is no surprise that site allocation affecting Rooksdown includes activity already scheduled e.g.
  - o **Barn site** revised planning application is in consultation showing use of site for 20 dwellings and the commercial use of the barn itself
  - o Old Golf Course in progress
  - o **Trumpet Junction** potential for revised plans to come forward
  - o Shop units planning application for luminous shop signage now progressing
- It will also draw attention to previous applications that may come forward again e.g.:
  - Manydown awaiting outcome of the LDF process to see what if any plans will be advanced for the land
  - o Aldermaston Triangle early discussions of use of this land are taking place

## **Open Forum**

- (i) A resident expressed concern about the position if the data from the recent traffic survey proves unsatisfactory in supporting our case for bus gates/traffic lights. CS confirmed that RPC would demand all traffic data, for discussion at the April meeting, in closed session if necessary.
- (ii) A resident expressed dissatisfaction regarding BDBC action regarding the continued existence of hoardings in front of the site of the former sales office on Park Prewett Road. CS confirmed that a planning application was in the pipeline to regularise this. RPC's response to this application will demand that the rubbish etc which is currently behind the hoarding, and clearly visible to residents living in houses to the rear of the old site office.
- (iii) A resident requested formal confirmation whether the play area in Parcel Drive is formally open. CS undertook to try to get that confirmation and action to landscape the neighbouring area.
