The housing market has slowed and that may mean further delays completing the Rooksdown site but we hope that this will not impact the community facilities. Talks are under way with the landowners. developers, Council and other interested parties to set a realistic timeline for facilities including the parade of shops.#

Park Prewett Pavilions

The Council conservation and planning officers held a site meeting at the Pavilions last month following complaints from residents about them being vandalised. A number of suggestions have been made to the developers including a change fencina and οf recommendations on types of safety glass which can be used without breaking the conservation

rules. It is hoped that the developers will respond to make these changes and to complete the placement of lighting around the Pavilions.

A339 bridge opens

As you will all have seen the new footbridge is now open and provides easier access to Wellington Terrace and the shops at Winklebury. There are no plans to close the old footbridge either both bridges appear to be getting good use.

Rat running through hospital

Hampshire Hospital, who own the roads and land through the hospital site, English Partnerships and developers are considering undertaking remedial works on the road surfaces which are breaking up across the hospital site. Repairs are expensive to undertake and the hospital are quick to point out that there is no public right of access across the hospital site. If the hospital authorities do undertake repair it is likely that they will also seek to reintroduce restrictions on access across the site over and above the signage in place. This will reduce rat running and ensure that the hospital can only be accessed from the A340 whilst Rooksdown will be accessible via A339.

Rooksdown Beat

I would like to take this opportunity to introduce myself as the Beat Officer for Rooksdown and the North Hampshire Hospital. I have been the Rooksdown Beat Officer for over 2 years. My role is to provide a visible presence on my Beat either on my bike or occasionally on foot. I am responsible for dealing with Anti – Social Behaviour, Neighbourhood Issues and working in a Multi – Agency approach to problem solving.

In comparison to other areas in Basingstoke, Rooksdown has a very low crime rate. The Pavilions that are situated off of Canadian Way have recently suffered an increase in Criminal Damage. Sadly they have been targeted by an element of children/youths that appear intent on causing vandalism/graffiti and anti social behaviour. These children/youths are very likely to be residents of Rooksdown. I therefore ask that parents ensure that they know where their children are at all times and what they are doing. The offences committed are criminal ones and they will be dealt with as such. I am working closely with Taylor/Wimpey and **Basingstoke and Deane Council** in order to find a long term

resolution to the vandalism and anti – social behaviour that the Pavilions have attracted. If you have any information regarding this matter then please contact me.

I do meet a lot of residents whilst out on patrol in Rooksdown so if you see me then please feel free to flag me down and speak to me.

Theft from vans has been a problem over the last few months. If you have a van then please ensure that the vehicle is locked and secured. Remove as much equipment/tools from the vehicle if it is to be left unattended overnight. This includes securing any external equipment, ladders etc. If possible try to reverse the vehicle up against your property to block access to the rear doors.

Please ensure that you do not leave valuables in your vehicle. Thieves will not hesitate in smashing a car window if they see any property left in an unattended vehicle. Even an old coat or bag could attract attention from a thief. To a thief it could contain cash, a mobile phone, a wallet or keys. Petty cash for car parking left on view could be an incentive for an opportunist to try their luck.

Composting for Results – The Questions and Answers? By Alan Bell

With the pressure to go green here are some tips on getting started with home composting......

Q. Now you've got your compost bin, where do you put it?

A. Ideally place it in open ground and preferably in the hottest spot in the garden – direct sunlight will produce quicker, more efficient composting results. If this is not convenient for your garden, out of sight works too - mine is in full shade and completely hidden but works wonderfully.

The bin is best placed on soil where worms are already established and can gain ready access to help break material down. Loosely forking the ground first and sitting the bin on top helps stimulate work activity.

Q. With your bin in place, what do you put into it?

A. When you get your bin you should also have an advice leaflet suggesting what to compost and what not to compost. Basically there are two groups of materials:

- **Greens** vegetable peelings, fruit scraps, weeds, old bedding plants, tea bags, coffee grounds and grass cuttings*
 - **Browns** garden pruning, dry leaves, hedge clippings, egg boxes, egg shells, toilet and kitchen roll centres, shredded paper, straw, hay, corn on the cob, cereal boxes (best roughly

torn up before composting – tearing up boxes and newspapers is a great way to get the children involved and uses some of that excess energy)

Use a mixture of greens and browns if you can. This will help to create a better balanced mixture for re-use in the garden.

*One word of caution about grass cuttings – cuttings can quickly mould and net together to create a messy yellow pulp. If using them in your compost bin it is best to layer them (in layers about 1-2inches deep) with alternate layers of other waste materials and fork them over from time to time to mix and aerate the compost.

Q. How to manage your compost bin?

A. When you have a balanced mix of materials composting in layers, you should keep the mixture moist. I also use a liquid accelerator which you can buy from any garden centre or DIY store – about 10ml liquid to 2 gallons water – but you can also get a granular type which you simply add to the layers as you compost or when you fork it through from time to time.

Finally - **do not** add cooked foods, raw meat or bones to the composting mixture, this will contaminate the mix and attract vermin.

How safe is your gas meter?

a result of enquires and concerns from number of а residents I have been in touch with GTC and subsequently gas regulatory bodies including Health and Safety Executive, Corgi and Energy Watch to find out exactly what it's all about. This short note is to inform you of what is happening. It is not safety advice and, if you remain concerned about your property you should seek the advice of an independent Corgi registered engineer or contact Corai or your supplier directly.

Firstly do not panic! I am aware that a number of households have served with gas safety warning notices as a result of the GTC maintenance checks. The safety notices effectively prohibit the use of supply until maintenance work is undertaken to remedy an

installation defect - see below. Do not worry unnecessarily: I am Recently, many of you will have assured by the gas industry received letters from GTC or their regulators that the installations are contractors PH Jones. The letters safe as long as they have been

> So what exactly is this all about? Firstly do you have a problem? Take a look at your gas meter box on your outside wall. If there is a gas pipe leading from the bottom of the box and into the house wall. then the following guidance does not apply to you.

> If however there is no pipe out of the bottom of the box, open the meter box. If, the gas pipe leads from the meter through into the house wall - read on.

The houses on the estate are fitted with medium pressure gas regulator valves. When houses were built medium pressure valves were not as common in domestic use as low pressure valves. The regulations governing their installation were still in development. However, the gas meters we have were installed according to guidance current at the time.

SAFETY IN THE HOME

This is purely a change in regulation as a result of better guidance however it does not mean the meters are inherently unsafe. What it does mean is that they need checking – hence the current round of visits.

Having spoken at length to Corgi and HSE they advise me of the following:

The current gas safety standard for medium pressure regulators is under review as a result of research commissioned by Corgi. The review may lead to a further change in guidance at the end of the year.

In light of this they advise that householders either:

 Do nothing at present but await the new guidance which may conclude current installations are safe and need no modification (as long as regularly maintained) or that they require some modification.

In the past 10 years the regulations have changed and now recommend that gas meters using medium pressure regulator valves should be fitted with the gas pipe leading from the meter out of the box and then into the house. It is now advisable under current standards - BS6400 Part 2 - that the gas pipe should not go through the back of the meter box.

I intend to follow up on the progress of regulations later this year and will send out another note when I know more.

• Undertake remedial works now to re-route the pipe-work out of the meter box and plug the hole left behind. This work will require the supply to be disconnected and re-connected and the work to be undertaken by a Corgi registered engineer.

I appreciate that this note does not give all the answers but it is intended to respond to a number of current enquiries and forewarn of what is happening.

Key points

The responsibility and costs of undertaking any remedial work to the meter rests in law with you the householder

The meters were installed correctly according to then current guidance so the likelihood of redress against the installers or developers is minimal – it may be worth checking your NHBC cover or household insurance however

You can be fined for ignoring the gas safety notice but HSE and Corgi assure me that they are unaware of such prosecutions – this may be different for landlords who have different suites of care to tenants

Householders and landlords are responsible for ensuring that gas supply and appliances are regularly maintained and for allowing access for engineers to undertake checks – as in the case of the current maintenance visits
