PLANNING UPDATE 16 JANUARY 2024

APPLICATIONS NEW SINCE LAST MEETING

- <u>24/00067/FUL</u> (Validated 15 Jan 2024) Change of use from Use Class A1/A3 to Use Class E Dentists
- <u>23/03137/FUL</u> (Validated 21 Dec 2023) Car Park. Greenlands Road. Installation of two rapid electric vehicle charging stations; two existing parking spaces will become EV charging bays, along with associated equipment.
- <u>23/03056/FUL</u> (Validated 18 Dec) North Hampshire Hospital, The Firs, Aldermaston Road. Construction of a new external entrance lobby, new conservatory extension and new windows, external render to all elevations, internal layout alteration and a new landscaped terrace. (Alternative proposal to that approved under 23/01937/FUL.)
- <u>23/03053/HSE</u> (Validated 12 Dec 2023) 8 Owen Way RG24 9GH. Proposed ground floor single storey rear extension following demolition of existing bay window.
